By signing the release of liability and using the Skate Park, The Participant and the Participant's parent or legal guardian (if under 18) hereby fully release and discharge The Salvation Army/Grind Youth Centre and the Evangelical Missionary Church of Canada from any and all claims, demands, damages, rights of action or causes of action present or future, resulting from or arising out of the Participant's use or intended use of the Skate Park and equipment.

The Participant and the Participant's parent or legal guardian (if under 18) agree to indemnify The Salvation Army/Grind Youth Centre and hold it harmless from any and all liability attributable to any personal injury, or loss or damage to property related to the Participant's use or intended use of the Skate Park and equipment.
